INSTRUCTION TO BIDDERS

- 1. This invitation for bids is open to all bidders.
- 2. The bidder shall bear all costs associated with the preparation and submission of its bid, and ANAW shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the disposal process.
- 3. The bidder is expected to examine all instructions, forms and terms in the bid documents and complete the forms as required namely, price schedule, bid form and the confidential business or personal questionnaire. Failure to meet all the requirements of the bid will be at the bidder's risk and may result in bid rejection
- 4. A prospective bidder requiring any clarification of the bid document may notify ANAW by writing an email to info@anaw.org with the subject as "Clarifications Bid for Disposal of Motor Vehicle". All clarifications/questions should have been sent to this email address by 5.00 PM on 13th October, 2020
- 5. ANAW will respond in writing to bidders by 5.00 PM, 14th October 2020 on any clarifications that will have been sought.
- 6. The bidder shall indicate on the attached price schedule for the vehicle
- 7. Prices quoted by the bidder shall be fixed during the bid validity period and not subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and will be rejected.
- 8. The price quoted shall be in Kenya Shillings (KES)
- 9. Bids shall remain valid for 21 days
- 10. Viewing of the bid items will be ongoing until 23rd October 2020 between 10.00AM to 3.00PM at ANAW Offices. Prospective bidders are encouraged to view the motor vehicle before they bid to enable them to arrive at the most competitive bid.
- 11. Bids are based on "AS IS WHEREIS CONDITION" and the conditions of the vehicle is **NOT WARRANTED BY THE SELLER.**
- 12. Any effort by the Bidder to influence the process will lead to automatic disqualification.
- 13. ANAW will award the contract to the successful bidder(s) whose bid has been determined to be substantially responsive subject to the reserve prices for the motor vehicle and discretion of ANAW management
- 14. ANAW will notify the successful bidder in writing and the successful bidder will be required to make payment within seven days (7 days) of notification of award.
- 15. In the event the successful bidder fails to pay for the vehicle awarded, ANAW shall notify, the person who had submitted the second highest bid who will be expected to make payment within seven days (7 days) of notification.
- 16. Once the payment is received by ANAW, the bidder will be expected to sign a sale agreement and undertake to collect the vehicle immediately.
